The **aCadabra™ Enchant® Acausal Outcome Facilitator** is an arcane energy focusing tool for facilitating the effecting of acausal outcomes through the maximisation of ethereal synergies to leverage alternate possibilities and unleash stakeholder delight.

The Acausal Outcome Facilitator is intended for use by recipients of magical gifts, second sight, or those with a proclivity for enchantment, whimsy, capriciousness, paradigm subversion, and general or localised silliness. It should only be used by recipients who are in possession or a strong sense of irony, or who can indicate irony to parents, caregivers, colleagues, or co-workers.

**Always utter conjurations when using the Acausal Outcome Facilitator to effect acausal outcomes.**

The Acausal Outcome Facilitator cannot be used remotely and should not be used with other magical accessories.

Testing shows the Acausal Outcome Facilitator can be used for up to 3 minutes if the recipient is able to sustain the utterance of conjurations for the duration of the spell.

The Acausal Outcome Facilitator can be re-used indefinitely, provided it is properly maintained, used in accordance with the instructions, and not used to effect evil.

Individual success in effecting acausal outcomes may vary depending on the quality of the uttered conjurations and the level of dexterity in the manipulation and manifestation of ethereal synergies and associated forces.

Do not use the Acausal Outcome Facilitator while undergoing an MRI, operating heavy machinery, or standing in the vicinity of Large Hadron Supercolliders.



## Grimoire


- 1 Grasp the Acausal Outcome Facilitator firmly in your dominant hand. Point it away from the body, in alignment with your axillary energy flows.



- 2 Gesticulate magically while uttering a standard or extemporised conjuration.




- 3 Allow an acausal outcome to be effected.
